Video Laryngoscope

Background

Effective airway management is a critical component of advanced life support care that our crews provide on a daily basis. Video laryngoscopy has become the gold standard in pre-hospital medicine as it improves first attempt success rates, reduces complications, and ultimately improves patient safety during advanced airway procedures.

Our crews currently utilize a direct visualization laryngoscopy method to place advanced airways. The visualization can be limited by patient anatomy, provider positioning, and environmental conditions. The addition of video laryngoscopy provides improved visualization of the airway features and allows for more consistent performance.

Evaluation

We conducted an evaluation of several video laryngoscope manufacturers, including McGrath, King Vision, and GlideScope, considering factors such as clinical performance, ease of use, blade options, and total cost of ownership. Based on this assessment, the GlideScope Go 2 was identified as the preferred option. Its EMS friendly design, clear color display, and availability of multiple disposable blade options make it well-suited for prehospital use. Additionally, the GlideScope Go 2 supports video recording and still photo capture, enhancing confirmation and quality improvement processes. It delivers reliable performance at a reasonable total cost, representing strong overall value.

Financial Impact

Total Purchase cost: **\$37,083.54**

Included: 14 GlideScope Go 2 devices, 14 carrying cases, and the initial disposable blade stock.

Funding Source: Capital Equipment Fund

Current Capital Budget: **\$38,000.00**

Ongoing Cost: Disposable blades and routine maintenance will be funded within the existing operating budget.

Recommendation

I recommend the purchase of 14 GlideScope Go 2 devices, cases and other associated supplies utilizing the Capital Equipment Fund for **\$37,083.54**.
